C. <u>Division Director's Report</u>

For the month of May the Division processed 152 retirements. There were 138 regular retirements, 3 Hybrid retirements, 7 Voluntary Pending cases and 7 new disability retirements. The Disability Unit was able finalize 10 disability cases for May.

For the ARP to Hybrid transfers there are a total of 1,939 with 453 retirees and 1,473 transfers, 4 prospective and 9 waivers. We continue to work through the backlog of transfers with 545 remaining to be completed. Two unpaid student interns from Manchester Community College started yesterday to assist the Division with backlog of transfers.

24 month review cases:

- Currently there are a total of 375 members to be reviewed. A 24 month review MEB meeting was held last month.
- Out of the 375 46 are currently collecting Social Security Disability leaving 329 that need to be processed for the 24 month review however 186 of the applications are awaiting medical information.

Last week there were twelve town units that were trained on using the Core-CT MERS Employer Reporting and the feedback on the system and processing was very favorable.

Deputy Comptroller Carlson gave an overview of the pension module. The Municipal Employees Retirement System (MERS) has now been implemented and continues to stabilize. There has been positive feedback from the MERS towns. The Division will continue to train the MERS towns on how to input the data. All modules in the implementation plan have been implemented. The consultants will be rolling off the project in June and Deputy Comptroller Carlson expressed concern that, due to budget constraints, \$2,000,000 was removed from OSC's overall CoreCT bond last year, and the \$2,000,000 funding is critically needed to finish stabilizing the system. She also stressed that the funds are not in excess of project cost projections, but within budget.
