At 10:18 a.m., Mr. Carey moved, seconded by Mr. Poulin to grant Mr. Barbagallo's request for reconsideration and schedule an appearance before the Commission. The Chairman asked if there was any discussion. There being no discussion he called for a vote. The Commission voted unanimously in favor of the motion.

At 10:19 a.m., Ms. Brown Brewton moved, seconded by Mr. Luciano to accept the recommendation of the Legal & Personnel Subcommittee on Mr. Krasinsky's request. The Chairman asked if there was any discussion. There was brief discussion that the Subcommittee recommended denial of the request. There being no further discussion, the Chairman called for a vote. The Commission voted unanimously in favor of the motion.

Adjournment

With no further business before the Commission, Mr. Luciano moved, seconded by Mr. Bailey to adjourn at 10:19 a.m. The Commission voted unanimously to adjourn.
