- DR. RUDICH: I'm calling -- the May 29,
- 3 2020 meeting of the Medical Examining Board is now in
- 4 session. I'm Dr. Lynn Rudich. With us is
- 5 Dr. Robert Galvin and Dr. Amarjeet Dargan. Present
- 6 from the Office of the State Comptroller Retirement
- 7 Services Commission are Annette Sadlowski,

- 7 DR. GALVIN: I have a question. Can we
- 8 vote for that continued enrollment, just read the
- 9 names and have one vote for the whole slate?
- 10 MS. CIESLAK: Yes, you may.
- DR. GALVIN: Okay.
- DR. DARGAN: Excuse me. Can you repeat
- 13 that question? I didn't understand.
- MS. CIESLAK: Dr. Galvin, just a reminder,
- 15 the recording is back on, so when you speak, you
- 16 should announce your name. That way the court
- 17 reporter knows who is speaking. I think I even
- 18 violated that rule.
- 19 So this is Cindy Cieslak, and
